The ACCME requires all individuals in a position to control the content of a CMDA activity to disclose all **relevant financial relationships** occurring within the past 12 months. The ACCME Standards for Commercial Support defines a commercial interest as any “entity producing, marketing, re-selling, or distributing health care goods or services consumed by, or used on patients.” ACCME does not consider providers of clinical service directly to patients to be commercial interests – unless the provider of clinical service is owned or controlled by an ACCME-defined commercial interest.

ACCME considers relevant financial relationships to create actual conflicts of interest when individuals have both a financial relationship with a commercial interest and the opportunity to affect the content of a CMDA activity about the products or services of that commercial interest. The ACCME considers content about the products or services of that commercial interest to include content about specific agents/devices, but not necessarily about the class of agents/devices, and not necessarily content about the whole disease class in which those agents/devices are used.

AGD/PACE - CE program providers must assume responsibility for taking steps to protect against and/or disclose any conflict of interest of the advisory committee, CDE activity planners, course directors and lecturer/author/ instructors presenting courses. Signed conflict of interest statements must be obtained from all advisory committee members, CDE activity planners, course directors and lecturer/author.
